As its commitment to advocate peace, the Department of the Interior and Local Government (DILG)-7 planted 18 peace poles – a widely recognized international symbol and monument to peace – in the Central Visayas Region.

Peace poles installed in the towns of the region, just like the rest of the monuments in the world, bear a message of "May Peace Prevail on Earth" on one of its four sides as a constant reminder to visualize and pray for world peace.

DILG-7 Director Leocadio Trovela wanted to take part in a movement that aims to bring inner peace of mind and to foster peace and positive change in the region.

Leading by example, Trovela installed a hand-painted peace pole inside the premises of the regional office in Sudlon, Lahug, Cebu City.

The towns in Region 7 that now have peace poles are Antequera, Calape, Clarin, Inabanga, Maribojoc, Sagbayan, Dumanjug, Sta Fe, Canlaon, Guihulngan, Guihulngan City, Mabinay, Manjuyod, Santa Catalina, Siaton, Valencia and Zamboanguita.

These local government units (LGUs) in Central Visayas have committed to promote peace and uplift the human consciousness within their community by installing peace pole.

Peace poles were installed during the widely conducted Dagyawan Sa Barangay 2020 as part of the Retooled Community Support Program (RCSP) and Ending Local Communists' Armed Conflict (ELCAC) efforts of the DILG-7 and the national government.

The Dagyawan sa Barangay composed of DILG-7 teams, personnel and other national government agencies, visited different barangays in Bohol, Cebu and Negros Oriental which was part of the RCSP targeted areas.

The team hosted a Talakayan (dialogue) with the communities and brought government services closer to the people through Serbisyo Caravan Para sa Mamamayan to the barangays.

In Bohol, the barangays visited barangays were Canlaas, Quinapon-an, Camias, Caboy, Caluwasan, Villafor, Bahan, Banahao, Cambituoon, Dagnawah, Lomboy, Maria Rosario, Riverside, San Jose, Sua, Candavid, Katipunan, Langtad and Mantalongon.

In Negros Oriental were Bayog, Budlasan, Lumapao, Binobohan, Hinakpan, Humayhumay, Imelda, Planas, Sandayao, Tacpao, Trinidad, Balogo, Nagsaha, Plagatasanon, Poblacion, Villegas, Bagtic, Luyang, Samac and Panciao.

In Cebu were Bulak, Paculob, Panlaan, Tangil, Tubod Bitoon, Tubod Dugoan in Dumanjug; and Bitoon (Kinatarkan Island) in Sta. Fe, Bantayan Island.

The peace pole at the DILG-7 office was installed in time of the Peace Day Celebration on December 8, 2020.

"This is our way of commitment as men and women for others. The way we interact with our peers, especially to our family and co-workers in our region reflects the way we treasure peace," said Dir. Trovela in his dedication message.

### 4T contact tracers hired

At least 4, 800 contact tracers were hired by the Department of the Interior and Local Government - 7 to be at the frontline in the region's massive attempt to break the chain of COVID-19 transmission.

They augmented the existing teams of the local government units in Central Visayas and will ensure accurate timely conduct of contact tracing activities and reporting of COVID-19 surveillance data.

On October 2, DILG-7 organized an online general orientation for the hired contact tracers to equip them with the sufficient knowledge and overview on how contact tracing works.

DILG-7 Director Leocadio Trovela formally welcomed the region's contact tracers and underscored their critical role in the fight against COVID-19.

"What you will do in the coming months is very important. We all know this is a risky job, but more than the risk is your love for your community neighbors, country," he said.

Richard Navarrosa and Harold Doroteo, technical coordinators of the World Health Organization-Philippines, discussed the basic principles and aspects of correct contact tracing that include policies, guidelines, ethical and legal issues, and tracing and management, while DILG-7 regional focal person on contact tracing Atty. Gerlyn Mae Sayson



explained the administrative requirements and terms of reference provided in the Contract of Service.

Police Regional Office-7 Director Albert Ignatius Ferro, Dr. Eugenia Mercedes Cañal of Department of Health-7, and Cebu City Mayor Edgardo Labella delivered their messages of support to DILG-7 and its contact tracers.

DILG-7 Government Local Monitoring Evaluation and Division Chief and DILG Cebu City Officer-in-Charge Atty. lan Kenneth Lucero, in his closing

message, thanked the contact tracers for joining DILG-7 in the fight against the unseen enemy.

"Let us break the chain of humanto-human transmission through effective and efficient contact tracing efforts. Let us beat this virus together. Be the gamechanger," he said.

Aside from the general orientation, the contact tracers were also oriented by their respective LGUs before their actual deployment from October to December 2020.



# RIATF7-MEID passes 95 resolutions

Since its inception, the Regional Inter-Agency Task Force-7 for the Management of Emerging Infectious Diseases (RIATF7-MEID) has passed a total of 95 resolutions and indorsed them to the National IATF either for its favorable and immediate decision or for information.

It also acted on the communications/requests received from local government units (LGUs), national government agencies (NGAs), other organizations, and private sector in the region, and disseminated IATF and other COVIDrelated issuances to LGUs, NGAs, and RIATF7-MEID members.

IATF Resolution No. 34, series of 2020 provides that the regions shall convene their **RIATF** with the respective regional offices of the Department of the Interior and Local Government (DILG) as chair and Department of Health Centers for Health Development as co-chair, which shall be a separate and distinct body from the Regional Task Force COVID-19.

In Central Visayas, the RIATF7-MEID is chaired by DILG-7 Director Leocadio T. Trovela and co-chaired by Department of Health (DOH)-7 Director Jaime S. Bernadas. The DILG-7 likewise provides the RIATF7-MEID Secretariat services.

The members of RIATF7-MEID, who are regional directors of the different national government agencies in Central Visayas, convene regularly and continuously collaborate to monitor the perfor-mance across all sectors and develop the appropriate recom-mendations.

The body is mandated to process the appeals to impose, lift, or extend community quarantine in provinces, highly urbanized cities and independent component cities.



It is also tasked to provide concurrence as appropriate to the appeals/requests of provincial governors to impose, lift or extend the community quarantine in component cities and municipalities, as well as of local chief executives of cities and municipalities in their respective barangays.

The RIATF shall report to the IATF Technical Working Group on matters of appeal for risk classification, with its representatives reporting to their national government agencies. It likewise decides upon any requests for the imposition, extension, and lifting of moratorium on inbound travel of returning residents of local government units, which shall be enforced by the National Task Force.

Considering that its decisionmaking is highly critical, the RIATF7-MEID takes into account the doubling rate of cases in the particular area, epidemiological curve and health capacity, parameters for zoning containment strategy, and absorptive capacity assessment of quarantine facilities, among others.

#### **AMID COVID-19 PANDEMIC**

### DILG-7 shares best practices in workplace

The unprecedented situation brought about by the ongoing COVID-19 pandemic prompted the Department of the Interior and Local Government (DILG) -7 to develop innovative practices to ensure the continued delivery of services to the public without compromising the health of its workforce.

The regional office, under the leadership of Director Leocadio Trovela, initiated the observance of hygienic measures to mitigate the spread of the virus and provide a safe working environment for its people.

Since the outbreak of the pandemic early this year and even prior to the implementation of the community quarantine protocols, Trovela has directed the regular checking of temperature of the employees using a thermal scanner.

It has also been the practice of the regional office to provide alcohol for each of its division and unit offices.

At the start of the outbreak, more alcohol and hand sanitizers were made available in the office, including the main entrance and for every floor.

When Cebu City where the regional office is located was placed under the Enhanced Community Quarantine, the DILG-7 has to limit the number of employees reporting for work and adopt alternative work arrangements.

Minimum health standards such as social distancing are also observed in addition to the existing sanitary practices.

Employees who are required to physically report to office are given free face masks, vitamins, and lunch every day.

The skeletal workforce are also provided with vehicular support daily, with the observance of physical distancing.

Both workers and walk-in clients are made to undergo foot bath before entering the office premises to prevent the transmission of virus. The regional office also installed plastic barriers at the Emergency Operations Center for the protection of the duty officers and walk-in clients.

All DILG-7 employees are also reminded to stay healthy and boost their immune system.

Creating a safe working environment that protects its people and clients is in line with the commitment of DILG-7 to make sure that the continued rendering of service to the public remains unhampered amid this quandary.



# DILG-7 retains ISO 9001:2015 certification

The Department of the Interior and Local Government (DILG)-7 added another feather to its cap after passing the second surveillance audit to keep the International Organization for Standardization (ISO) 9001:2015 certification conferred in 2019.

The second surveillance conducted by Worldwide Quality Assurance (WQA) Philippines showed data on DILG-7's innovation and continued implementation of the global standard for quality management system under the leadership of Regional Director Leocadio T. Trovela.

Certification to ISO 9001:2015 means that an organization or office has been audited by a third-party certification body and has been found compliant with the internationally accepted standards for quality management and processes.

DILG Central Visayas received the conferment in 2019. It has passed the 2020 surveillance anew despite the challenges posed by the COVID-19 pandemic.

Assistant Regional Director Maria (ARD) Loisella E. Lucino, who heads the Local Governance Resource Center, said ISO certification isn't given on a silver platter as it can be revoked if an organization or office fails to follow the recommendations from last year.

ISO certification is renewed every three years and will undergo surveillance every year during that three-year span.

"We did it despite the changes due to the pandemic. We owe this to the employees of DILG-7," she said.

ARD Lucino explained that the main reason for the ISO certification is to make the life of employees easier with the use of simplified steps within the global standard.

"When we do our program, these processes are institutionalized and internalized by our employees. It simplifies the work," she continued.

ISO 9001 is an internationally recognized provider of a framework for a quality management system. It delivers a framework for monitoring and measuring performance and operations, ensuring efficiency and customer satisfaction.





# 15 SCOs served on CV barangay execs



A total of 15 show cause orders (SCOs) were issued this year to Punong Barangay (PB) and their Sangguniang Barangay (SB) members in Cebu City (13), Lapu-Lapu City (1), and Negros Oriental (1) directing them to explain why they should not be charged for failure to perform the mandated duties and functions of a local chief executive during a state of national health emergency.

The Department of the Interior and Local Government (DILG) - 7

gave these barangay officials 48

hours from receipt of the order to submit their written explanation.

Alleged violations in Cebu City and Negros Oriental were nonobservance of quarantine protocols such as mandatory wearing of face masks, social distancing, strict home quarantine, and prohibition on mass gathering, while in the case of Lapu-Lapu City, supposed nonobservance of protocol on the burial of persons having COVID-19 suspected thereof reported.

DILG-7 Director Leocadio Trovela directed DILG-7 Local Government Monitoring and Evaluation Division Chief and DILG Cebu City Officer-in-Charge Atty. Ian Kenneth Lucero and LGMED lawyers to serve the SCOs.

Earlier, DILG Secretary Eduardo Año said that any violation of the quarantine protocols will not be tolerated and those responsible will be made to account.

### DILG-7 8888 Unit acts on 432 complaints

A total of 432 complaints were received and acted upon by the Department of the Interior and Local Government (DILG) - 7 8888 Unit from August 26 to December 20.

Majority of the complaints received by the region pertain to integrity-related concerns such as complaints against government officials/employees and against government regulations.

DILG-7 made sure that the complaints referred to the agency were acted upon promptly and accordingly.

The agency judiciously acts over complaints referred by the Center and any referring agency for the matter, and endeavors to continue being the Center's good partner in the fight against red tape and corruption.

### Road clearing resumes







Efforts of the local government units to clear public roads of any encroachments and illegal obstructions resumed on November 16, the Department of the Interior and Local Government announced.

On October 27, DILG Secretary Eduardo Año issued Memorandum Circular 2020-145, which sets the new guidelines on the implementation of the road clearing directive of President Rodrigo Duterte.

The effort forms part of the COVID-19 response and recovery interventions under Republic Act Bayanihan to 11494, or the as One Act, which provided for the regulation of traffic on all roads, streets and bridges and removal of

encroachments and illegal constructions in public places.

DILG-7 Director Leocadio Trovela stressed that while there was a significantly high LGU compliance rate of more than 90 percent in the region during the last road clearing effort, he hopes that LGUs will sustain the gains and even aim for a higher compliance rate, this time.

He said that there will be full implementation of the road clearing in the region since all provinces and highly urbanized cities are already under Modified General Community Quarantine.

"This road clearing directive is a continuing activity that requires sustained effort and implementation.

It is also our way of ensuring that our roads are safe and free from hazardous encroachment and to implement effectively social distancing measures as we gear towards the new normal," he explained.

LGUs are given until January 15, 2021 to carry out the provisions in the memorandum.

DILG-7 thru its field offices have worked closely with the LGUs and different stakeholders to get a full compliance to the presidential directive on road clearing.

As of December 15, 2020, 2,223 out of the 3,003 barangays (74.03%) in the region complied with the directive.



### NGAs hold Dagyaw reg'l town hall

Government agencies and private sectors convened on November 5, 2020 in an effort to address concerns affecting employment and livelihood sectors amid the coronavirus disease (Covid-19) pandemic.

This was the highlight of the discussion during this year's Dagyaw Open Government Virtual Town Hall Meetings.

This year's Dagyaw carried a theme "Usapang Lokal: Ugnayang Trabaho" as it focused on helping the Filipino workers recover from the adverse impact of the pandemic to the livelihood of the Filipinos working here and abroad.

The organizers of Dagyaw 2020—the Department of the Interior and Local Government (DILG)-7, Department of Budget and Management (DBM)-7 and the Philippine Information Agency (PIA)-7—invited the Civic Society Organizations (CSOs) to grace the whole-day activity at the Ecotech Center in Lahug, Cebu City.

"We are so proud to have this gathering of partners, massive at that, and the broad participation from the CSOs, NGOs (nongovernmental organization) and the private sectors who joined us in the government in the discussion about the effect of Covid-19 and the interventions of the government that all of us had to undertake," DILG-7

Leocadio T. Trovela said in his virtual message to the participants.

Twenty-five CSOs from the sectors of urban poor, labor and vendors were invited at the Ecotech Center, while the guest speakers and other participants from Region 7 attended thru Zoom.

Meeting for Central Visayas is the
continued intent of the
government to open communities
towards the opportunities that are
available for everyone.

Governors Arthur C. Yap of Bohol Province and Roel Degamo of Negros Oriental also shared their message of support to the participants.

"In this time of Covid-19, there's no room for any of us to do our own thing. We must all continue to spend funds and implement programs for the maximum impact. We can't do our own projects without consulting each other and that is exactly what we are doing today," said Yap.

"Our provincial government looks forward to a fruitful collaboration with national government agencies, CSOs, business community, academe, and the community for a more dedicated and productive way to serve our people. May this townhall meeting serve its purpose well," Degamo said.

The resource speakers for the event were from the Department of Labor and Employment (DOLE)-7, Technical Education and Skills Development Authority (TESDA)-7, Department of Trade and Industry (DTI)-7 and the Cebu Chamber of Commerce and Industry (CCCI).

Supervising Labor Employment Officer Ma. Terese Doria Tanquiamco spoke for DOLE-7, Regional **Operations** Division Chief Welkie E. Reroma represented TESDA-7, SME Development Division Chief Marivic V. Aguilar talked for DTI-7, and Felix Taguiam for CCCI.

The event capped off with a workshop with CSOs on the Regional Multi-sectoral Agenda as part of the co-creation process for the sixth Open Government Partnership (OGP) National Action Plan.

Last year, Dagyaw pushed for localized dialogues with stakeholders at the grassroots level to provide an avenue for pitching their concerns and feedback directly to the local government officials.

The term "Dagyaw" is a Hiligaynon term for "Bayanihan."

### Dagyawan promotes peace, development in Dumanjug

With the aim to widen people's to government, access Department of the Interior and Local Government (DILG)-7 and other government agencies assisted six targeted barangays in the municipality of Dumanjug in the formulation of their proposed project plans under the Retooled Community Support Program (RCSP).

Barangays Tubod Dugoan, Tubod Bitoon, Bulak, Panlaan, Tangil and Paculob culminated the week-long activity in Dumanjug with a handover ceremony of their Refocused Barangay Development Plans to the chairman of the **Dumanjug Municipal Planning and** Development Council, and to the Municipal Peace and Order Council.

"We will make sure that we will allocate funds as far as our budget is concern. Kana rapud ang kutob sa atong makaya. Ang di makaya ato ning e-forward ngadto sa provincial government," Dumanjug Mayor Efren Guntrano "Gungun" Z. Gica told constituents.

The Dagyawan sa Barangay 2020 featured a series of dialogue, consultation, solution-seeking discussion, workshop, and medical services-including a free flu vaccination to the vulnerable senior citizens and blood donation drive. The installation of the peace pole in front of the Jose S. Macov Memorial Gym on November 16 was one of the highlights of this year's Dagyawan sa Barangay. The peace pole signified a commitment to advocate peace and positive change. It internationally-recognized symbol that brings the message "May Peace Prevail on Earth."

"What we are doing today is an offshoot of the Dagyawan sa Barangay 2020. This is a platform and bottom-up planning that serve as a venue for active engagement between the government and the people. This brings us government closer to the hearts and the mind of the people," said DILG-7 Regional Director Leocadio T. Trovela in his message.

He added that the development council at all levels will play a significant role in the progress of these proposed projects. "The aspirations of the community that have been laid down in the Barangay Development Council should find its way to the budget process of the Regional Development Council and eventually

to the national level." Trovela stressed.

For her part, DILG- Cebu Province Provincial Director Jhoaden G. Lucero said that the whole activity embodied togetherness and unity among the people of Dumajug who are working together to promote development and peace.

Congressman Peter John Calderon, meanwhile, said that he would do all the efforts so that these projects will be realized.

BK is a flagship program of the DILG encouraging the involvement and participation of various stakeholders in the fight against corruption down to the grassroots level.





### **RPOC-7 convenes**

Members of the Regional Peace and Order Council - 7 convened on December 3 for the fourth quarterly meeting for 2020 to tackle status and developments on peace and order in **Central Visayas.** 

The meeting was presided by RPOC-7 Chair and Cebu City Mayor Edgardo Labella, who was assisted by Atty. Ian Kenneth Lucero, officer-incharge of the Department of the Interior and Local Government (DILG) Cebu City.

Concerned agencies delivered situation reports on peace and order, drugs, terrorism and insurgency, and maritime safety administration and security.

DILG-7, led by Director Leocadio Trovela as member and Head Secretariat, provided technical support and assistance during the meeting.

Dagyawan sa Barangay aims to bring the government closer to the people.


### DILG-7 pushes for protection of children's rights

media practitioner Former and photojournalist Iste Sesante Leopoldo, who now heads the Public Information Office (PIO) of the Municipality of Cordova, said the webinar was very informative and useful, especially to the members of their PIO team who don't have any journalism experience.

### **DILG-7 graces inauguration** of COVID-19 facilities in Cebu

Seven new health care facilities for treatment and isolation of the COVID-19 positives were turned over to the cities of Cebu, Mandaue and Lapu-Lapu, Cebu Province and the Mactan Cebu International Airport Authority (MCIAA).

The new facilities in Cebu City are the Cebu City Quarantine Center (CCQC), the Department of Public Works and Highways (DPWH)-7 Regional Office at the South Road **Properties** and the Apas **Evacuation Center.** 

The other three facilities are situated at the Mactan- Cebu International Airport, Hoops Dome in Lapu-Lapu City, North Bus Terminal in Mandaue City, and the Correctional Institution for Women at the Cebu Provincial Police Office.

projects were made possible in collaboration with the concerned national govern-ment agencies, the local govern-ment units of Cebu, Mandaue, Lapu-Lapu and Cebu Province, and notably the MCIAA.

DILG-7 Director Leocadio Trovela said that the facilities are a manifestation of the readiness of the government to address COVID-19 concerns such as the treatment and isolation centers.

"Region 7 is very fortunate to have the national government agencies and the government officials collaborating to make these facilities possible," Dir. Trovela said on his message at the Mactan-Cebu International Airport facility in Lapu-Lapu City.

The seven facilities will become the permanent treatment and isolation centers as the country now embrace the "new normal," said DOH-7 Regional Director Jaime S. Bernadas.

For MCIAA general manager Atty. Steve Y. Dicdican, the facility inside the airport will help in getting back the confidence of the people to return to their normal lives.

Over at the CCQC, Cebu City Mayor Edgardo Labella said the City of Cebu was going in the right direction on its efforts to stop the local transmission of COVID-19.

OPAV Assistant Secretary Jonji Gonzales said that the facilities are products of the convergence, collaboration and the strong determination of the government to serve the people amid this pandemic.






### **Barangay Assemblies conducted**

**Pursuant to Department of** Interior and Local Government (DILG) Memorandum Circular No. 2020-137, all barangays were allowed to conduct their **Barangay Assembly Day for** the Second Semester of CY 2020 on any of Saturdays or Sundays of October and November in light of the existing IATF guidelines.

The Barangay Assembly Day theme was dubbed as "Barangay Bayanihan sa Panahon ng Epidemya Para sa Kaligtasan ng Mamamayan".

Highlighting the assembly was the reading of the message of Secretary Eduardo Año who called for the promotion of unity and discipline within the barangays to maintain the peace and order in the communities.

Field officers were required to submit a monitoring report on the compliance of the barangays to this Circular. Out of the 3,003 barangays in the region, 2,468 barangays (82.18%) have conducted BA for the second semester of 2020.



# Orientation on updated BDCP guidelines held

Department of the Interior and Local Government (DILG) – 7 gathered all its provincial and city directors and Anti-Drug Abuse Council focal persons and program managers for an orientation on PDEA Memorandum Circular 2020-026 or the Omnibus Procedures in Declaring a Drug-Affected Barangay as Drug-Cleared under the Barangay Drug Clearing Program (BDCP).

DILG-7 Director Leocadio Trovela said the webinar is designed to promote awareness among local sanggunians current initiatives of the national government on peace development.


"This is a demonstration and manifestation on the importance of the role of sanggunian. We want you to be fully informed so we can formulate responsive legislation," he told the attendees.

Trace. Test. Isolate. Treat. These were among the strategies shared by the Cebu City Government in a webinar organized by the Department of the Interior and Local Government-7 (DILG-7) on October 23, Friday afternoon.

Mayor Edgardo Labella, in his speech, said the city came up with its own playbook in combating the dreadful coronavirus disease (COVID-19).

"Mass testing allows us to identify infected persons in our community; isolating them helps us stop the spread of the virus; we then treat them to help them recover; and we track who they've interacted with to also test them. And the cycle continues," he said.

DILG-7 Director Leocadio Trovela commended the city government and all local government units in the region for showing their creativity and innovations in dealing with the health crisis.

"For our region, it is but fitting to showcase the remarkable effort of Cebu City, under the leadership of Hon. Mayor Labella. The city has demonstrated remarkably yung efforts nila sa COVID-19. Now, Cebu and the whole of the Central Visayas are regarded nationwide na naging

successful--at this stage at sana ma-sustain yung efforts natin in this pandemic," he said.

Trovela said the webinar was part of the regions' series of online activities conducted via Zoom and Facebook live in celebration of the Local Government Month 2020.

It was attended by officials and representatives from different LGUs in the region, DILG-7 division chiefs, provincial and city directors, DILG field officers, and personnel from the DILG regional office.

Other best practices shared by Cebu City is the allocation of P1 billion for COVID-19 relief and response efforts, purchase of PCR machines, rapid tests kits, and negative-pressure ambulances.

The three-day activity was made possible through the collaboration of DOH-7, DILG-7, Department of Social Welfare and Development-7, Office of the Presidential Assistant for Visayas, Cebu City Government, Provincial Cebu Government. Ramon Aboitiz Foundation Inc., and React Philippines.

It was initiated by DOH - Central Visayas Center for Health Development pursuant National Blood Services Act of 1994 or Republic Act 7719.

The activity aims to facilitate the accessibility of sufficient blood supply in the region and the country, especially in this time of pandemic.

Highlighting the event was the commitment signing officials and representatives of the participating NGAs, LGUs, and private sectors vowed to establish linkages and mobilize all sectors to participate in the initiative, among others.

DOH-7 Director Jaime Bernadas, in his speech, encouraged the public assist the government in promoting the initiative to "regain hope, save lives, and bring smiles."

Knowing the impact of the event, Trovela committed that the regional office will encourage other LGUs to replicate the same initiative in their areas.





### DILG-7 holds dialogue with vendors, youth leaders in USAP 2020



Cebu City vendors and youth sector representatives aired their concerns and insights during a dialogue dubbed as Ugnayan ng Sector at Pamahalaan (USAP): Capacitating Urban Communities for Peace and Development at the Ecotech, New Dining Hall in Sudlon, Lahug, Cebu City on December 17, Thursday.

The Department of the Interior and Local Government (DILG)-7 initiated the activity which aimed to provide a venue for productive, valuable, sincere and visible engagement between the government and its citizens at the level through direct engagements.

The first part of the whole-day convergence was designated for the vendors, while the afternoon activity was scheduled for the youth leaders.

"The nation wants the local economy to rise. Talagang sadsad ang local economy, not just in Cebu but nationwide," he said.

"Sama-sama nating tugonan ang pandemic. Sana mabalik natin ang sigla ng local economy, malaki ang tiwala namin sa sector niyo."

Meanwhile, Cebu's youth leaders engaged in a productive discussion with DILG-7, the Department of Agriculture (DA)-7, the National Youth Commission (NYC), the Technical Education and Skills Development Authority (TESDA)-7, and development partner World Vision.

The NYC discussed the "nine centers" of youth participation, while DA-7 and TESDA-7 talked about the basic services offered by their department.

For its part, the World Vision, a nonprofit organization, explained the structure of Community Managed Savings and Credit (CoMSCA), a saving mechanism that allows a group of people, especially those living in rural areas to manage their own saving and credit system.

# DILG-7 highlights best practices, accomplishments of Lupong Tagapamayapa

The Department of the Interior and Local Government (DILG) - 7 highlighted the good practices and accomplishments of the Lupong Tagapamayapa in Central Visayas in settling disputes at the community level.

DILG-7 Director Leocadio Trovela was chosen as a member of the panel while Local Government Monitoring and Evaluation Division Chief and concurrent DILG Cebu City Officer-in-Charge Atty. Ian Kenneth Lucero served as the resource person during Episode 8 of the KP webinar series on the Office for Alternative Dispute Resolution (OADR) last November 27.

Lucero presented a step-by-step guide in the mediation process starting from the cause of action until the termination proceedings. He also discussed the forms used in the mediation process especially the samples of amicable settlement and provided possible scenarios during the mediation process.

In his closing remarks, Trovela emphasized the crucial role of the Lupong Tagapamayapa in helping the government relieve the congestion in our court dockets as well as save billions of pesos since most

of the cases have already been resolved as early as in the barangay level.

Each case that the Lupon is able to settle saves the government P9,500 which is the estimated adjudication cost.

"In Region VII alone, close to 80% of the cases referred to the Lupong Tagapamayapa in CY 2019 were settled by the Lupon, thus helping the government save an estimate sum of P307 million," he said.

To capacitate the Lupon, DILG-7 organized two webinars on the jurisdictional and procedural aspects on KP Law and rules on venue as part of the celebration of the Local Government Month in October.

Trovela then assured the participants of the continued support of DILG-7 to the local government units in the speedy administration of justice. He likewise congratulated OADR for the success of the webinar series and for making DILG-7 part of the activity.

### DILG holds webinar on Katarungang Pambarangay Law

Acknowledging their vital contribution in settling disputes amicably, the Department of the Interior and Local Government (DILG) – 7 capacitated the members of the Lupong Tagapamayapa to enhance their knowledge and expertise on barangay justice.

DILG-7 Director Leocadio Trovela said praised the efforts of the Lupon especially in settling disputes in

the community level and avoiding the indiscriminate filing of cases in court.

"Congrats and thank you to the members of the Lupon, especially the Punong Barangay and members of the Sangguniang Barangay. You are helping us relieve the courts of the crowded dockets," he guips.

Resource speaker DILG-7 Local Government Monitoring and Evaluation Division and Cebu City Officer-in-Charge Atty. Ian Kenneth Lucero challenged the attendees to apply what they have learned from the two webinars.

"You have always been our frontline defense of the government in all battles, may it be against COVID-19 or against lawlessness and criminality, and the speedy administration of justice in your level. Good luck and mabuhay kayong lahat," he adds.

### **DILG-7 joins ICT/BPM Online Summit**

The Department of the Interior and Local Government (DILG)-7 joined the first edition of the two-part online summit on Information and Communications Technology (ICT) /Business Process Management (BPM) hosted by the Cebu Chamber of Commerce and Industry (CCCI) in celebration of Cebu Business Month on Wednesday, October 21.

DILG-7 Director Leocadio Trovela, who was invited as one of the panelists, discussed the government's Standard Operating Procedure, reforms set by the Republic Act of 1103 or the Ease of Doing Business Law and the interventions initiated by the agency in response to the EODB Law to cut redundant bureaucratic processes and streamline business procedures in the local government unit.

Trovela highlighted the key areas of EODB Law which includes the simplified process of acquiring Building Permits and Certificates for Occupancy, and Business Permits and Licensing System (BPLS), as well as the Rationalization of Fees and Charges and Passive Telecommunications Towers Infrastructures (PTTIs).

The virtual activity highlighted the vital role and initiatives of the government as well as the industry's efforts to recuperate and strengthen the economy devastated by the onset of the pandemic.

He talked about the national government's initiatives to improve the ease of doing business particularly for the ICT-BPM industry in the country such as the reforms introduced under the EODB Law and the results achieved so far.

In relation to the EODB Law, DILG, in partnership with government agencies, has implemented interventions to promote ease of doing business at the local government level such as Building Permits and Certificates of Occupancy; Business Permit and Licensing System; Rationalization of Fees and Charges; **Telecommunications** Passive Infrastructures.

Also discussed were the pertinent provisions under the Bayanihan to Recover as One Act or Republic Act 11494 pertaining to the ICT-BPM industry.

Trovela said he plans to strengthen compliance of LGUs with EODB Law and other ICT-BPM related government initiatives by partnering with other government agencies such as DTI and DICT among others.

"Opening the doors to a digital future of E-Governance where service is faster and better for the Filipino people," he said.



He returned to the Philippines in 1892, but was exiled to Dapitan by Spanish authorities.

He was convicted of sedition and was eventually executed on December 30, 1896, at age 35.

### **DILG-Mandaue** City sets up text hotline

The enhanced contact tracing effort was a joint endeavor of different national government agencies such as Department of Health, DILG, Philippine National Police, Armed Forces of the Philippines and Bureau of Fire Protection.



### Webinars on KP Law held

Lupon Chairmen, Lupong Tagapamayapa members, Lupon Secretaries, and Sangguniang Barangay members in Cebu City and other parts of the country joined the two webinars on Katarungang Pambarangay (KP) Law organized by the Department of the Interior and Local Government (DILG) - 7 to enhance their knowledge on barangay justice.

The webinars were part of the celebration of the Local Government Month 2020 in October.

DILG-7 Local Government Monitoring and Evaluation Division Chief and DILG Cebu City Officer-in-Charge Atty. Ian Kenneth Lucero served as the resource speaker for the two webinars on jurisdictional and procedural aspects on KP Law and rules on venue.

He presented the substantial provisions of the law, illustrative cases, and Supreme Court decisions.

Lucero challenged the participants to apply what they have learned from the two webinars.

It was followed by Barangay Guadalupe as first runner-up and Barangay Kalunasan as second runnerup, which bagged P30,000 and P20,000, respectively and plagues of recognition.

In Region VII alone, close to 80% of the cases referred to the Lupong Tagapamayapa in CY 2019 were settled by the Lupon, thus helping the government save an estimated sum of P307 million.

This was an initiative of the Province to fast track the processing and release of salary and other allowances of the hired contact tracers.

### **DILG Siquijor holds CoRe Advocacy Campaign**

The Department of the Interior and Local Government (DILG)-Siquijor Province recently conducted the Constitutional Reform (CoRe) Advocacy Campaign on December 2, 2020 at the Fumiko Rina Acoop Resort in San Juan, Siquijor.

The campaign aimed to promote awareness and engaging the stakeholders on the current government's condition, as well as to educate and

enlighten them on the reason why there's a need to reform the 1987 Philippine Constitution.

The participants were various stakeholders including the Sangguniang Kabataan (SK) and Liga ng mga Barangay Provincial and Municipal Presidents, members of Civil Society Organizations (CSOs), youths and DILG Siquijor personnel.



### **Training on GAD-PBMS** conducted in Siquijor

The Department of the Interior and Local Government (DILG) Siguijor Province thru its Provincial Gender and Development (GAD) focal person conducted training on GAD-Plan and **Budget Monitoring System (GAD-PBMS) to the** municipal local government operations officers on September 1, 2020, at the DILG Provincial Office.

The hands-on activity aimed to orient the participants on the system and on how to encode Plan and Budaet Accomplishment Report in the GAD-PBMS.

GAD-PBMS is an automated system that is used to address the common diversity of reviewing, commenting, and endorsing the GAD Plan and Budget as well as the GAD Accomplishment Reports in the local government units.

### Disiplina Muna advocacy launched in Bais City

The Disiplina Muna advocacy and the Bida ang Disiplina: Solusyon sa COVID-19 rolled off in Bais City to raise awareness and instill public discipline, especially in this global health crisis.

The Department of the Interior and Local Government (DILG) Bais City in partnership with the Bais City Philippine National Police (PNP) launched these advocacy campaigns on August 28, 2020, at the Barangay Cabanlutan.

PMsgt. Edzilfroy Laxina led the recitation of the Disiplina Muna pledge and discussed the pillars of Disiplina Muna campaign which include road clearing, disaster preparedness and resilience, antismoking, liquor ban, tourist spot cleanup and functionality of the Barangay Anti-Drug Abuse Council (BADAC).

### Siquijor creates **Provincial Task Force** for COVID-19

The Siguijor Provincial Task Force for COVID-19 didn't put their quards down in the battle against the coronavirus disease as it regularly conducted meetings to address pressing issues and concerns related to the pandemic.

The Provincial Task Force COVID-19 held bimonthly meetings to discuss concerns in relation to the impact of the pandemic on the global safety and the life of all the Siguijodnons.

Siguijor recorded its first two positive cases of COVID-19 in August. The task force convened to address the matter and brainstormed to come up with the best possible solution.

The patients who tested positive for COVID-19 were all asymptomatic.

### 300K attended virtual seminar on KP Law

The Department of Justice - Office for Alternative Dispute Resolution (DOJ-OADR) conducted an webinar entitled. educational "Katarungang Pambarangay" on the KP Law, including ADR Mechanisms and Techniques thru Zoom and FB Live on August 20, 2020.

This webinar was in coordination with the Department of Justice (DOJ) and Department of the Interior and Local Government (DILG)-7 to provide more insightful discussions and address commonly asked questions on KP Law for an efficient and speedy administration of the barangay justice system.

An estimated 300,000 graced the webinar. Attendees were Barangay officials, members and DILG personnel.



# DILG Cebu City personnel undergo drug test

Personnel of the Department of the Interior and Local Government Cebu City led by Officer-in-Charge Atty. Ian Kenneth Lucero voluntarily submitted themselves to a drug test on November 25.

This was in support of the city government's program on ensuring a drug-free workplace. Lucero said public officials and government employees should act as role models for the public. All of them were found negative for illegal drugs.

### **Outstanding BADAC**

The Provincial Validation Team composed of the representatives from the Department of the Interior and Local Government (DILG) Province, Philippine Drug Enforcement Agency Negros Oriental Provincial Office and the Provincial Anti-Drug Abuse Council visited Barangay Cangmating, Sibulan Negros Oriental on September 30, 2020 to conduct the Evalua-tion/Validation for the search of outstanding Barangay Anti-Drug Abuse Council (BADAC).

The activity was attended by DILG officer Rosalina Villegas, PSSg Joemil A. Malipaonon and members of BADAC headed by Punong Barangay Gil Estrellado.

### CCPOC convenes; POPS Plan approved

Members of the Cebu City Peace and Order Council (CCPOC) convened twice in CY 2020 with the objective of keeping all members abreast of the prevailing peace and order situation and addressing related issues and concerns amid the pandemic.

During its first regular meeting, CCPOC deliberated and passed resolutions authorizing the release and utilization of confidential funds; appointing the three other members of Enforcement People's Law convening of the Administrative Board for drug-related public nuisances; establishing the Balay Silangan and Balay Paglaum; giving utmost priority to the request of Cebu City Jail for the procurement of equipment that will help jail personnel detect contrabands; and seeking representation in the Supreme Court for the establishment of drug court in Cebu City Jail.

On its second regular meeting on November 12, it deliberated and approved the draft Peace and Order and Public Safety Plan which embodies the three-year direction of the Council and aims to improve life in the community through measures that fill in the gaps in the peace and order and public safety situation in the city.

### DILG Siquijor pilots RBME virtual workshop

The Department of the Interior and Local Government (DILG) Siquijor Province piloted the first virtual training workshop on Synchronous and Asynchronous Learning for the Results-Based Monitoring and Evaluation. The seven-day training workshop was held from July 13 to 17 and July 20 to 21, 2020 at the Provincial Governor's Office in Pulangyuta, Siquijor.

The workshop was conducted via Microsoft Teams and the participants had the option to join either individually online or attend personally at the Provincial Governor's Office.



### **BHERTs** expanded

The Barangay Health and Emergency Response Team (BHERT) in Cebu City has been expanded, primarily in its composition.

The Expanded BHERT is now composed of the Punong Barangay as team leader, Sangguniang Member particularly Barangay chairperson/member of the Committee on Health or Women and Family as action officer, and other volunteers such as representative/s from the Organizations Barangay and Civil Society Organizations operating in the barangay, sitio leaders, two Barangay Health Workers, and Barangay Public Safety Officers.

Meanwhile, the USAID's ReachHealth Program, in collaboration with the DILG-Cebu City, designed a training program entitled "Strengthening BHERTs During COVID-19 Pandemic" especially for those barangays with the most number of cases.

In partnership with Bidlisiw Foundation and DILG Cebu City, USAID also conducted microplanning workshops to identify and address the gaps and challenges affecting containment strategies.

### Fights vs. illegal drugs

Amid ongoing COVID-19 crisis, government continues to undertake its efforts in eradicating illegal drugs, especially in barangays.

Since October 2020, the Barangay Drug Clearing Program (BDCP) has been rolled out to 33 barangays in Cebu City wherein barangay officials and members of the Barangay Anti-Drug Abuse Council attended the series of training.

This was spearheaded by the Philippine Drug Enforcement Agency, Cebu City Police Office,, Department of the Interior and Local Government, and Cebu City Office for Substance Abuse Prevention (COSAP).

After the rollout, the authorities visited the residences of verified drug personalities of the said barangays and encouraged them to surrender. Continuous monitoring of the status of drug surrenderers/personalities is also ongoing.COSAP likewise moved for the strengthening of the Community-Based Drug Rehabilitation Program, which was launched in 32 barangays as of this writing.

### **DILG Cebu City joins EOC** huddle

The Department of the Interior and Local Government (DILG) Cebu City participated in the daily morning huddles of the city's **Emergency Operations Center every morning** from Mondays to Fridays.

During the meeting, authorities assess the COVID-19 situation in the city based on the recent data gathered from the concerned agencies.

### Siquijor starts 3-phase innovative strategy

The Department of the Interior and Local Government (DILG) Siguijor Province thru its Initiate has institutionalized the Cluster implementation of the 3-Phase Strategy.

The strategy focuses on DILG-LGU contractor project inspection/monitoring, ioint on-site quarterly project status assessment conference and action planning workshop, and SubayBayan Portal updating.



### **CCDRRM** efforts strengthened

The Department of the Interior and Local Government (DILG) Cebu City has been regularly present in the Cebu City Disaster Risk Reduction and Management Council (CCDRRMC) weekly meetings wherein updates on the status of the city in terms of disaster prevention and management are discussed.

On September 10, the plan and budget of CCDRRM Office (CCDRRMO) for CY 2021 were reviewed and harmonized before being presented to CCDRRMC.

DILG Cebu City also participated in the strategic planning activity of CCDRRMO on September 25 that aimed to set its direction for the upcoming years and strengthen the partnership between DILG and CCDRRMO.

On October 21, Officer-in-Charge Atty. Ian Kenneth Lucero and LGOO III Emmanuel Pedralba also attended the Cebu City Fire Advisory Council meeting to establish protocols and standards during fire incidents.

### **LCAT VAWC activities held**

A series of online activities for the Local Committee on Anti-Trafficking and Violence against Women and Children (LCAT-VAWC) were conducted to enhance the knowledge of barangays.

These activities included consultation on the operationalization functionality of LCAT VAWC/local experience in protecting children and their rights during COVID-19 on November 3; webinar series on anti-trafficking in persons on

November 9 and 11; online national orientation of diversion toolkit for duty bearers at the barangay level on December 2; and culminating activity of the 18-Day Campaign to End VAW on December 14.

Department of the Interior and Local Government Cebu City focal person LGOO VI Socorro Dorina Salas also participated in various inter-agency focus group discussions on LCAT VAWC.

### **DILG Cebu City facilitates GAD workshop**

The Department of the Interior and Local Government (DILG) Cebu City has reviewed the Plans and Budget (GPB) and Annual Accomplishment Report (GAAR) of the 73 barangays in Cebu City and issued corresponding Certificate of Review and Endorsement (CRE) as one of the required attachments of the barangay's Annual Budget.

GPBs of those barangays that opted to amend/realign their plans were also reviewed.

DILG Cebu City facilitated the GAD planning workshop for CY 2021 for the members of the Sangguniang Barangay and GAD Focal Point System (GFPS) of Barangays Banilad and Apas on December 3 and 11 respectively, in response to their requests for technical assistance. On December 9, it also conducted an orientation on GAD and other related laws for the members of the re-organized Women's Council and GFPS of the city.


